What experience do you bring to the table to make you a successful mayor?

My leadership experience and community connections will make me a valuable and successful mayor. This includes my experience on Pullman's city council, my long-term involvement in the community, the relationships I have developed with community leaders through working with them on community projects, and my understanding of other Washington communities. I have served 13+ years on Pullman's city council and understand mayoral time commitments along with what is expected and city processes. Heidi and I have lived in Pullman for over 35 years, we raised our family here, started a business, and are very involved in the community. My service as co-chair of Pullman 2040, on the boards/leadership of the Pullman Chamber of Commerce, Kiwanis, Pullman Community Council on Aging, One Palouse, Town Gown, Downtown Pullman Association and Innovia along with volunteering for many other community organizations gives me broad insight into the community and experience promoting community desires. My service on the board and as president of Association of Washington Cities provided connections and

insights into other communities and how Pullman compares. As a result, I have identified areas where Pullman should improve, what connection and resources are needed, and have developed plans to make these improvements.

What do you see as the role of city government in economic development?

It is important for the city to be actively engaging in and investing in the economic development of the Pullman community. For too long, our downtown's standard has been based on another community. When I was growing up, the roles were reversed, and Pullman set the standard. It is time for Pullman to set the bar once again, not just with our downtown but in all areas of economic development.

The city's involvement needs to include a developed long-term economic development vision and plan which includes the support and involvement of the mayor and staff working to advance the plan, economic development projects, and public private partnerships. In parallel to the economic development plan, there also needs to be continued investment in the underlying supportive infrastructures structures which include multimodal transportation networks able to handle traffic demands, completion of the downtown project to promote downtown vibrancy, development of a transportation by-pass to reduce downtown congestion, and a long-term sustainable water supply. The city should also be actively engaged in and connected with the various entities actively supporting community economic development.

What are your top priorities for the city's infrastructure and how would you plan to address them?

Completion of the downtown project to promote downtown vibrancy

The first phase is on track for implementation during 2024. I will work for downtown businesses to minimize construction impact while keeping the project on track.

Advancing a transportation bypass to reduce downtown congestion

We won't fully solve the downtown issue without advancing a bypass. This will be a significant project similar to the airport. We need to first identify the preferred route, make sure the community supports the route plan, and then focus on funding and implementation.

Identifying and implementing solutions for a long-term sustainable water supply

Right now, the city's community focus is on conservation education and implementation. Conservation won't solve the issue by itself, but an alternative water supply is also needed. The Palouse Basin Aquifer Committee is narrowing down preferred water supply options. As Mayor, I will be actively involved in this process.

Growing our multimodal transportation networks to handle traffic demands

Our community members don't restrict themselves to just driving and our transportation efforts need to ensure we focus on all modes of transportation.

Development of College Hill Safe Routes

I am working with the Town Gown, College Hill Association, and WSU to identify non-vehicular college hill routes. The next step is to evaluate the routes to ensure there is adequate lighting, safety, infrastructure, and then develop a plan to provide the necessary upgrades to these routes. Once College hill is complete, we will then implement a similar process for the rest of the community.

What will you do as mayor to advance Pullman's sense of community and welcoming atmosphere?

We are in a society often divided into opposing groups which at the state and national level do all they can to attack and tear each other down. I don't feel that this should be the norm for our community. For Pullman to thrive we need to get to know our neighbors, appreciate the experiences and value that each person brings to our community, focus on the areas and issues which we have in common, and come together and jointly tackle our community challenges.

What are your top priorities for the city's infrastructure and how would you plan to address them?

A robust city plan must allocate funds for infrastructure growth and maintenance well in advance of population growth. Long-term planning, including the creation and upkeep of roads, sidewalks, water/sewer systems, electricity, transportation, and personnel, is crucial for Pullman's success.

What do you see as the role of city government in economic development?

I see city government as a partner with business owners, landowners, the Chamber, WSU and the Downtown Pullman Association in economic development. We represent the city's residents and ensure that citizen interests and concerns are considered in the economic development process. All entities involved deserve to be heard, and we have to work together to do what is best for most in our community. During my tenure on Council, the City created an Economic Development position, and this person is instrumental in assessing the current business environment and looking for opportunities to expand and attract businesses to our area. They also work closely with consultants who are hired to gather information which helps guide the decisions that come before the Council. The City is also invested in the Downtown Pullman Association, both financially and with a member of the Council on the DPA board. I presently hold that position. I have always had a strong interest in economic growth and providing opportunity for business, especially small business, so involvement with DPA is particularly meaningful for me. I have worked for large corporations as well as single-proprietor businesses and have a good understanding of the needs of each.

What are your top priorities for the city's infrastructure and how would you plan to address them?

My priority is to continue to support the infrastructure projects the city currently has as well as future projects. These include, but are not limited to, completion of the airport terminal project as well as future growth if needed, continued support of our police and fire units including future growth and improvement of existing facilities when feasible, supporting our transit operations to ensure service is available to as many residents as possible including our Dial-A-Ride service, and supporting our maintenance and operations staff in their work providing essential services and keeping our infrastructure safe and updating as needed. I believe that 'supporting' infrastructure is not equivalent to always pouring more money into infrastructure. Infrastructure occasionally requires investment, to improve, expand, and repair, and through sound financial planning, we are usually able to address these needs Otherwise, I believe that infrastructure is best supported by championing its value, educating myself and others about its operations, encouraging outreach by the providers, and being actively engaged in learning about new developments.

What will you do as a council member to advance Pullman's sense of community and welcoming atmosphere?

I believe community events are a great way to bring citizens together and extend greetings to new residents. I haveworked the Lentil Parade and Festival for many years and I love connecting with people who I haven't seen in a while and meeting new people who want to know about life in Pullman. I enjoy the Pullman Farmer's Market and I promote it to my friends and co-workers. I am interested in creating additional community events such as the

3 Forks River and Arts Festival that can be held downtown or in one of our beautiful parks. I annually attend the Association of Washington Cities meetings and I like to talk to representatives of other Pullman-sized towns about the events that they stage in their communities. If I am re-elected, I would love to try to develop a few of these ideas for Pullman.

What steps will you take to make Pullman a better place to live, work and do business?

I will continue to advocate for all our community has to offer. From our library to our Downtown businesses, to employment opportunities throughout our city, our beautiful parks and our excellent school district, I believe in the exemplary quality of life we have here in Pullman. I regularly share information about events in our community, and I enjoy providing information to those who are new to town.

What do you see as the role of city government in economic development?

tremendous change and I look forward to serving during this dynamic period in our community.

The topic of economic development is very extensive and has changed significantly over the years. City governments can assist in retention, recruitment, providing communication and streamlining business requirements for development and regulations. The city can help economic development by providing infrastructure extensions and improvements, zoning, permit and regulatory assistance. I believe working closely and communicating with the business sector is important to determine what practices are preferred or most effective, while looking at other communities for successes.

What are your top priorities for the city's infrastructure and how would you plan to address them?

Road maintenance cost is currently outpacing our budget and we are actively seeking new funding sources. I have advocated that we need to rate our paved areas and address repairs in a data driven "needs and use based" way, instead of our traditional practice of rotating repairs, thereby avoiding wasting resources on areas where they are not needed. Beyond this, rail lines inside city limits should be converted to trails and emphasis on our waterways will provide additional lifestyle draws for our city. The Downtown core is of utmost importance along with an alternate route for heavy truck traffic to redirect around the downtown area, creating a more walkable and pleasant atmosphere.

What will you do as a council member to advance Pullman's sense of community and welcoming atmosphere?

I have always believed that it's important to attend local events ceremonies, celebrations, and shop local businesses. I enjoy attending events that are often underrepresented or need a little more attention and help. I also seek out some of the groups and organizations that are newer or not as well-known so that I can gain a little more insight into our ever-changing community. As councilmembers we should be sharing this information on social media and in person while answering questions and concerns and providing a positive supportive atmosphere for everyone. It's important for me to encourage, grow and advise new groups and leadership in our city and region, many community members have great ideas but can feel discouraged, left out or forgotten as I have on many occasions. Furthermore, I believe in regional collaboration and working across borders for the

betterment of all of us, we can collaborate and compete at the same time, showcasing all our cities through a regional lens. Lastly, I remain open and available for anyone to contact me at all hours and days.

What steps will you take to make Pullman a better place to live, work and do business?

Over more than a decade I have often advocated for projects that were a little "before their time" at the city. Some have included advocating for social media communication in 2008 when I was first on Council, or GIS in 2012, or a warming shelter in 2018. I make it a point to find opportunities and successes that we can try here, even if it takes a little longer to find how to make it work for our community. My current priorities include increasing housing options and availability, mental health and QPR training for all, advocating for and creating a VA satellite location in Pullman and utilizing Blue Zone research and the organization to create a healthier retirement, and longer-lived population in Pullman.

My experience as a multi-business owner in Pullman for the past decade has given me a deep understanding of the economic and social dynamics of our town. I've seen firsthand the challenges that businesses face, especially when it comes to navigating local regulations and accessing resources. This experience has taught me the importance of a business-friendly environment and the need for proactive support from the local government.

In addition to my business background, my three years of volunteering as an EMT in the Seattle area and my active involvement in the Pullman community have given me insights into public service and community needs. I have served on the Pullman City Council since February, 2008 and have been involved in most aspects of municipality governance from zoning changes, human resource management (interviewing and hiring key city positions including City Administrator, Finance Director, Police Chief and Commander, Economic Development Director; reviewing and approving multiple labor contracts) city planning decisions including approval of a revised comprehensive plan; partnering with WSU on a variety of initiatives (Town Gown Collaborative, Downtown Pullman Association, regular meetings with ASWSU, The Gateway Project and New Cougar Orientation)supporting tourism through various Lodging Tax Advisory Commission activities including securing a new service contract with the Pullman Chamber of Commerce; Strong support of Public Safety organizations (Police and Fire); Understanding the many challenges facing Public Works such as snow removal, public transit, street and sidewalk improvement, major projects and how they impact citizens, ecological concerns with storm water management and conservation and lastly, climate awareness; Review

of Parks and evaluation of Recreational programs through administration of the Metropolitan Parks District and associated events. I have been involved with many community organizations including serving on the Boards of the Pullman Chamber of Commerce, Innovia Community Foundation, Pullman Regional Hospital Foundation and Auxiliary, Pullman Education Foundation and United Way. All of these activities have broadened my knowledge and experience in working for the benefit of others and evaluating situations that touch people's lives and livelihoods. I will continue to develop and enhance connections and relationships that make Pullman the amazing city that it is.

What do you see as the role of city government in economic development?

City government must play an integral role in economic development, and it does so by evaluating key strategies not only for improving a community's business landscape but also by understanding the challenges inherent in attracting and retaining businesses, facilitating business development and assisting existing businesses to realize success. City government through economic development understands the strengths and weaknesses of the local economy and identifies where gaps exist in meeting the needs of the community and how to best close those gaps by offering accurate, up to date and credible information to prospects interested in investing, locating or expanding in a specific area. City government can also provide information on the community needed by local businesses and industries and how to facilitate the critical partnerships between the public and private sectors. Economic development must continually evolve to meet the needs of existing businesses as well as to evaluate the current need in the community. In addition, and more specifically, city government through economic development partnerships ie. Chamber of Commerce, Downtown Association, WSU other government agencies and private sector businesses can network existing businesses, conduct business visitations, launch targeted industry studies as well as labor market surveys, track vacant business sites and facilities and initiate and attend meetings with stakeholders.

What are your top priorities for the city's infrastructure and how would you plan to address them?

- 1. Completion of the downtown Pullman project which will improve and promote the vibrancy and people centric aspects of the redesign and the master plan. Inherent in this is also the attention to multi modal access supporting the needs of all users whether they choose to walk, bike, use transit or drive...more connections and more choices.
- 2. Identify a viable bypass to downtown so heavy and long-haul transporters can utilize an alternate route thus creating a safer, more ambient area to provide those people centric locales as referenced above. The right bypass location must be identified and cooperation with partner agencies, ie. Washington Department of Transportation,

Whitman County, Washington State Legislature and commodity groups currently transporting shipments through the downtown corridor developed to maximize efforts to completion.

3. Continue to support current conservation practices through irrigation regulation and compliance as well as to identify alternate sources of water supply that would complement our current source through the Palouse Groundwater basin.

Our partnership with and support of The Palouse Basin Aquifer Committee is critical in evaluating the additional sources available in our region.

- 4. Evaluate an aging infrastructure of pipes, sewer, waste management disposal and proactively develop a plan for updating and replacing these critical elements.
- 5. Continued emphasis on paths and trails and enhancement of those gems that are within our purview.

What will you do as a council member to advance Pullman's sense of community and welcoming atmosphere?

First and foremost, it is the responsibility of an elected official to be a role model for the community. It is important that we embrace the sense of community and belonging, and we do this by making sure that we are aligned in what we say we value and what we actually value. Transparency and consistency are critical in providing information (as in regulations-rules need to be administered equally, e.g., building permits and inspections). We must be partners with our constituents and treat them with dignity and respect. Our city staff are our subject matter experts, and it is critical to acknowledge their level of expertise, trust their judgement and again, demonstrate respect even when there may be some level of disagreement. It is important for people to feel valued, and I try to do this whenever I can, and I believe my actions speak for themselves. I take a balanced and even-handed approach in working with people and hope that by doing so, I can instill confidence that I try to do the right thing in evaluating situations and making decisions. In my mind, that is the best thing I can do in instilling a sense of community and welcoming.

What steps will you take to make Pullman a better place to live, work and do business?

I have served on the Pullman Chamber of Commerce Board of Directors since 1989 and was part of the Board that adopted our mission statement of making Pullman a better place to live, work and do business. I embraced this concept from its inception. Living in Pullman is special, and I attribute that to having a great healthcare system, an exceptional school district and being a safe place to raise a family. I further that by continuing to support those attributes in our city goals and priorities. I can, through support of a vibrant business community, encourage the availability of goods and services (shopping, dining, recreating) and shopping and dining locally to show that support. Pullman is an extremely philanthropic community, and it is in this philanthropy that we promote the welfare of others, contributing to a food bank or making available a warming or cooling shelter when needed. Lastly, we must understand and explore all the challenges of providing affordable housing. This involves reviewing zoning regulations, offering access to alternative and innovative housing solutions such as ADUs and mitigating some of the affects of these changes on existing residents.

Businesses are affected by a community's rules and regulations and how easy (or difficult) it is to work with the municipality. It is incumbent upon us as elected officials to ensure transparency and consistency in our application of those regulations and assisting businesses whether they be contractors, someone opening a store front or providing a service in reaching success.

Pullman has been my home for years, and I've had the privilege of being involved in several community initiatives. My role as the Executive Director of United Way of Whitman County was particularly transformative. It was during this tenure that I championed the introduction of Dolly Parton's Imagination Library to our region, ensuring that every child 0–5 years old has access to free monthly books. My position at WSU's Financial Aid Office provides a unique perspective, allowing me to understand the complex challenges our students grapple with daily. This experience deepened my resolve to build a more equitable Pullman.

But beyond these official capacities, our campaign stands out for its unwavering commitment to bridging the communication chasm between Pullman's residents and its decision-makers. We've all felt the ripples of disconnect in today's politics, and our campaign is a beacon of change in this landscape. Our bi-weekly community conversations, held over a beer at Ricos or coffee at Neills, are more than just discussions; they're a testament to

What do you see as the role of city government in economic development?

Additionally, I look forward to being involved in the next steps in Project Downtown Pullman. The reconstruction of Main Street between Spring Street and Grand Avenue, planned for 2024, promises a more "people-centric"

downtown. This project will not only enhance our infrastructure but also create vibrant spaces that draw residents and visitors alike to the heart of Pullman.

What do you see is the role of a school board member? School board members listen and learn, and then make decisions that align with the community's vision for its schools. It concerned me that no one eligible for this particular position stepped up during the regular filing period earlier this year. Pullman has long attracted families and businesses that believe in the value of education for realizing the full potential of our children and community as a whole. That's a real strength for us, and shows how investing in education early in life is a long-term investment in innovation, civic engagement, and meaningful careers. We should welcome partnerships and opportunities that help students connect their K-12 education with future careers and community service. District 2 includes a lot of adults and parents who are also in school continuing their education, often while working multiple jobs, and the school board also needs to support working parents who are

All of this is really about the day-to-day interactions that happen in our schools, and teachers and staff are the experts there. balancing a lot of roles that benefit our community.

This was further fortified by being enrolled in FFA throughout my high school years, and learning the value of working together for a common goal; by treating all with humility, compassion, kindness, and civility. After an honorable discharge from the Navy, I attended college, and began serving our church through meals on wheels, assisting neighbors through St.

Francis Guild and St. Vincent DePaul food and clothing drives. I have continued to serve in these volunteer positions my entire life.

While at the College of Veterinary Medicine at WSU, I served on the Academic Affairs committee for the university, reviewing curriculum changes, overseeing disciplinary actions, and reviews of college programming. During my academic career, which spanned 46 years, I also served on several USDA grant review panels, as well as, review panels within the College of Veterinary Medicine.

I was first appointed to the Pullman School District (PSD) Board of Directors in 2007, and have served diligently since that time. I consider the School Board to be an intricate part of the community, and we, as members, take an oath to serve the People of Pullman, Whitman County and the State of Washington with the utmost care – There is nothing more valuable than a youth's education.

The challenges facing the school district are: Those pertaining to student access to state-of-the-art academic curriculums; assuring quality teaching; continued monitoring of school safety; academic assessments; those involving new technology, such as artificial intelligence; and providing the resources (classrooms, buildings, etc.) required for our schools to work for the students, and the community, at a high level.

Challenges can either be viewed as obstacles, or as opportunities. I, and those School Board members I serve with currently, and with those I served with in the past, have always viewed them as opportunities. This helps immeasurably, as the School Board listens, weighs the impact upon the school district, does its homework and after input from our community constituents, takes action by approving, disapproving, or modifying the recommendations presented to us by the administration.

The role of a School Board member is to first, and foremost, be an advocate for all the students on their learning journey; this is followed closely by being supportive of the teachers, the parents, the PSD staff, and the community they represent. Initially, this advocacy and support can be daunting, but with experience, a supportive Board team, and policies and procedures that provide guidance, the School Board member shifts from promoting individual agendas to governance via the Board team.

Each year the School Board of Directors reviews and signs a document entitled "Operating Principals/Board Protocol (Policy 1101, Procedure 1101F), which are in place to enhance teamwork amongst the members, and between the School Board and the Superintendent. The School Board has a responsibility to represent the community in its mandate to provide a quality education for all students. The Board becomes a vital link between all six schools and the community, by maintaining an active and ongoing connection with members of the community. This is accomplished by listening to community voices, concerns and expectations, and then, reflecting upon expressed values, concerns, and expectations in making board decisions. The School Board member must be engaged in the community by participating in the day-to-day activities of the schools. This may be done by being part of PTA/PTO's, contributing informative dialogue at meetings, and writing articles for the Pullman Community Update – See August, 2023 issue for article, "Life changing experiences through Career and Technical Education (CTE)."

We are very fortunate to have within our community, businesses and institutions that provide for post-secondary pathways for students interested in careers and civic engagement. I had chosen the military route after high school, then college afterwards. For some students, careers in computer-digital applications; agricultural sciences – business, medical-dental fields; and electrical-mechanical-hydrodynamics-metals trades are always in search of curious students. The pathways our students seek are vast, and the jobs within our community and beyond are diverse and in need. Career exploration for our students is available through course offerings, school counselors and teachers.

Opening educational opportunities, that transition into career and work force opportunities are manifested through the imaginations of our children and grandchildren, the remarkable skills of our teachers, and the encouragement of parents and grandparents.

I have been fortunate to have served as a Board member for the PSD for the past 16+ years. This experience has taught me that change within the educational field is very dynamic. Keeping ahead and responding to these changes requires continual refining of our Board skills to keep pace, and to maintain a vision for the future needs for optimum student learning, teacher engagement and proficiency, and administrative leadership.

In order for me to be supportive of our teachers, staff and administrators, I must understand what changes they are undergoing in terms of curricular changes, the student's emotional and social well-being, the current and proposed budgetary projections, and the state-of-the school districts' facilities to create a safe learning – teaching environment. This knowledge is facilitated by the Board's experience, their ability to work together, their participation in periodic work sessions, and the annual meeting of the Washington State School Directors Association.

Something I have personally tried to do while on the school board is to treat all teachers, staff and administrators with dignity, respect, and a sincere attitude, that I, through my efforts on the board, will help to address the challenges and changes aforementioned.

In summary, I see my role on the school board as one who tries to listen and clarify issues as early as possible; to be consistent in my support of all whom I serve; and to embrace the challenge of serving the Community through being a School Board member of the Pullman School District.
