

# Required & Common Vendor Documents

*Please submit application, payment, and copies of all required permits to Pullman Chamber of Commerce.*



***Each vendor is responsible for knowing what permits are required for their business operation. The list below is a sample of permits and licenses that may be required to sell your products at the Pullman Farmers Market and is not meant to be exhaustive. Submit current copies of all relevant licenses and permits with your application.***

## **Business Licenses** (required for all vendors):

- Washington State Business License, \$19
- Out of State Vendors may be exempt from applying for a WA State business license. Please visit <https://dor.wa.gov/find-taxes-rates/retail-sales-tax/marketplace-fairness-leveling-playing-field/remote-sellers> to determine your status.
- City of Pullman Non-Resident business license
  - \$0-\$2,000 in reported gross annual income earned within city's limits, exempt
  - >\$2,000 in reported gross annual income earned within city's limits, \$15
