PARTICIPATING BUSINESSES WILL BE LISTED ON A WEBPAGE ON THE CHAMBER WEBSITE (BUCK\$ WILL INCLUDE A QR CODE TO ACCESS THIS PAGE).\* THERE WILL ALSO BE A LIMITED SPONSORSHIP OPPORTUNITY TO HAVE YOUR BUSINESS NAME & LOGO FEATURED ON THE BACK SIDE OF THE BUCK\$.

CHAMBER BUCK\$ WILL ONLY BE SOLD AND REIMBURSED IN SET INCREMENTS (TBD) AND SHOULD BE ACCEPTED AS CASH AT FULL FACE VALUE. CUSTOMERS USING BUCK\$ TO MAKE A PURCHASE LOWER IN COST THAN THE VALUE OF THE BUCKS SHOULD BE GIVEN THE APPROPRIATE AMOUNT OF CHANGE IN CASH. THE BUCK\$ WILL BE REDEEMABLE AT FULL FACE VALUE VIA CHECK TO YOUR BUSINESS. SIMPLY MAIL OR DROP OFF YOUR REDEEMED BUCK\$ AT THE CHAMBER TO BE INCLUDED IN THE NEXT CHECK PRINTING CYCLE.
